To The Honorable Judge Joseph A. Smyth:

Dear Honorable Judge Smyth,

Sir, I would like to thank you in advance, for taking the time to read this letter. My name is Dorothiea Roberts. I am a 55-year-old Black Woman. I am the mother of one daughter, age 38, and a 35-year resident and homeowner of Montgomery County Penna. I am due to appear before you on April 27th. 2006, case no. CP-46-CR-0005207-2005:

Sir, this case that is due to come before you on April 27th. stems from a 15-year investigation against me and my daughter by the Montgomery County District Attorney's Office, F.B.I, and the Department of Justice as well as the National Security Agency, as well as the Media. Sir I know how bizarre the facts of this case are, one would have to ask oneself, why would a black woman, and her daughter who both have never committed a crime in their lives, come under such an investigation? Well the answer to that question is very simple, racism, politics, greed, and blind ambition and lawlessness, on behalf of both Mike Marino and Bruce Castor, as well as members of the Horsham Police Dept and the Media, and other Government Officials, Presidents, etc. To think this all started with a black woman, returning home from church and finding her home had been broken into, and doing what any other law biding citizen would do, "call the police". That is all that I did Sir, only it was the wrong thing in this situation here in Montgomery County PA. because the persons who were breaking into my home were police officers, and members of the media. There has not been a day since this first happen back in 1990, that I have not asked myself, why didn't somebody stop Bob DelSoldo and Dave Wolf, and the other Horsham policemen, and members of the media, and members of Bright Hope Baptist Church, from continually breaking into my home, when it first started. Bob DelSoldo, told me on the day that he was taking me to Building 50 of the Norristown Sate Hospital that, were he had me 302 committed, because I had caught him breaking into my home, that "I should have taken his advice and got my black a.. out of my home when he had told me too, and that he was teaching me a lesson". At the time I would not believe that a Policeman could put a person into a mental hospital and claim that they were mentally ill, because the person had identified him as having committed a crime against them. But DelSoldo has shown us all that it can happen, especially if you have a corrupt District Attorney, who is only interested in his political career, and getting media

attention, and cares nothing about justice, as Bruce Castor and Marino does. I understand that I was supposed to have expected that there was nothing I can do about this situation being that such high level government officials are involved. Sir, I have no intention of complying with these acts of racism, that are being employed against my daughter and myself. The District Attorney has used disinformation, false information, made up information to discredit my daughter and myself, so they can employ these illegal and dehumanizing acts of racism against us, with every member of the congress and senate bearing witness, as well as the media and presidents. It is very scary Sir, because none of them seem to even be aware that they have broken every law that this country is hinged on and their own oaths of office, and they are proud of having done so.

I have been charge with having made terrorist threats by commutations, for just employing my constitutional rights to ask why my daughter and myself are being surveillance and monitored in our home, yet the District Attorney feels it is not a crime to place in my home and that of my daughter's cell phones, mine, and our home phone, and cars and microphones in even our bathroom, and allow media, government officials etc., to listen in at their will. I know that what Castor is implementing against me and my daughter is indeed harassment by commutations, not me calling him, to inquire why he is taking this action against us. These are the facts. Not a delusion. I have to wakeup every morning knowing that even while I was sleeping I was being violated by being taped and recorded, and that members of the Media and government, etc. could listen in. It is only thru the Grace Of God, that I have made it this far.

Judge Smyth, for the last 15 years my daughter and myself have been forced to live under conditions that I Pray that no other person on the face of this earth, will ever endure in their life. I have been subjected to illegal arrests about 14 times, and committed illegally to Norristown Hospital where I was wrongly diagnosed as being paranoid, delusional, schizophrenia. During this time, I lost my home in Horsham, and everything I owned, due to the cover up by the DA's office concerning the breaking and entering into my home. What has happen to me here in Montgomery County will forever have an devastating effect on my life and that of my daughter. I will never because of the false stigma of mental illness, and the false arrests and sham prosecutions of me, used by the D.A. to cover up the illegal surveillances, and wiretapping of my home, and now my daughters, be able to pass a security clearance in order to obtain employment, or buy a home. What I have been subject to due to this lawless and blatant acts of racism on behalf of Castor and Marino, and Government Officials, Presidents, etc. is a disgrace to the very premise of freedom and an outrage to the Constitutional laws of this country, and its founders.

I wish I knew how to write well enough to convey to you how horrifying and degrading the last 15 years of our lives has been for my daughter and myself. Sir, Mike Marino as well as Bruce Castor and the Media, as well as other Government Officials, Presidents, etc. has shown blatant, criminal disregard for my daughter's and my life as human beings. Never in the history of law enforcement have I ever

heard of anyone being treated so intentionally criminally inhumane publicly as we have by The District Attorneys, Police, and F.B.I. Media, Government Officials, Presidents etc.

Sir, I am enclosing a copy of the letter that I have written to the Attorney General, Alberto Gonzales some time ago. I had hoped that he would have dealt with this matter, instead I got more denial, and run around. This letter will explain in detail what is going on here in Montgomery County and why. Honorable Judge Smyth, I want you to know that I have always known from the very beginning, that a complaint had been filed against me by State Rep. Louise William Bishop and an ex. Congressional Aide of the ex. Congressman William Gray, William Raymond. Sir their complaint against me was in retaliation to my having advised a young mother, there at Gray's Church to seek legal help, when she came to me crying that her son was being molested by William Raymond, at Bright Hope Baptist Church, where he was a Deacon. At the time Sir, that I told this young woman to go to the Police, I did not even know that she was speaking of William Raymond. But Sir, even if I had of known, I would have still told her to go to the Police. I don't believe that anyone in this country is above the law. I have the highest respect for the laws of this country and I have raised my daughter to respect them also, as I was raised.

my daughter is 38 years old, she has lived since age 23 in this hideous, disgraceful situation created by the district attorneys and media, government officials etc. since age 23. she has never been in any trouble with the law. She has worked at her job for 19 years now, earns in the excess of close to \$95,000.00 dollars a year, and is a wonderful young woman. What Bruce Castor, Mike Marino and the Government are implementing against us is destroying her slowly. She tries not to show it, but I am her mother and I know her. She has stood beside me during everything that has taken place these last 15 years. It has been very hard for her she loves me Sir, as I love her, She works very closely with the Media, as part of her job, doing trade shows, for Motorola Inc. in Horsham PA. She travels a lot both in and out of the country, and has been subjected to this surveillance and wiretapping even while away on business, in her hotel room, office phone, cell phone etc. as well as here in her home. Sir, Mr. Castor nor any other Government agency has any legal reason for the wiretapping of neither her nor myself.

Sir, I have lived on the face of this earth 55 years, and I want you to know that I have never threaten or even thought of doing harm to another person in my life. I have never been in any trouble with law enforcement other then back in November of 1984, when while out for the evening I loaned my girlfriend my rental car, and it was identified as having been the car that was driven by a woman who was the cause of a fire, somewhere in Philadelphia. This incidence grew out of an auto accident, which occurred in Philadelphia on Stenton and Haines St., where I was seriously injured when I got caught in the middle of a Police chase of a suspect driving a stolen car. My girlfriend was a passenger in my car. After this accident, I had to rent a car. I was out one night about a month later and I loaded my rental car to this same girlfriend, to run back to her home to pick up her wallet, which she said

she had forgotten when she changed pocketbooks. I later learned that when she got to her home, her boyfriend was there and she and him, went by the house of the man who was driving the suppose to be stolen car to get their insurance information, and that is when the fire happen.

I never even knew about the fire until I was subpoenaed to testify for the 14th District Police Dept., in Philadelphia at City Hall, and was told that the sister of the man who I was to testify against, that the Police had been chasing at the time of the accident, had identified my rental car as having been the one driven by the woman the night of the fire, where a cigarette was thrown into a bag of trash that was on the front porch, and the fire Marshall said that is what caused the bag to catch on fire. The day that I went to testify on behalf of the 14th. District Police Dept. which was about 3 months after the incident of the fire, the Assistant District Attorney asked me what type of car was I driving, and where had I rented it from. I told her, she then told me that a fire had been started at the home of the man that I was there to testify against and that his sister had described the woman and man that had come to their home, to get their car insurance information and that a fight had taken place between the man that was with the woman, and her father, upon which the Police was called and they came to break up the fight, and that the fire had started after the Police had made the man and woman leave. The sister described the woman as being light skinned, and about 5'11 or taller. The Police Officer that answered the call said that he had spoken to the woman and the man, and he described the woman the same as the sister. The Police officer also described the car that they were driving; it was indeed the car that I had rented after I had got caught in the Police chase, and mine was totaled. The Assistant District Attorney told me that a warrant had been issued for my arrest and that I should turn myself into the Police dept. I was outraged, I tired to tell her that I knew nothing about a fire, she assured me that it would be straighten out, but I would have to first turn myself in to the Police, because they had identified the car as being mine, I did as I was told. About a year later when the case finally went to trial, after many continuances, I was found guilty, I was sentenced to 11 ½ months to 23 months of work release, with furloughs on the weekends, which meant I would have to report to the YMCA in Philadelphia, where they were doing the Work Release Program, every night at 11:Pm and leave there in the mornings at 7:Am.

I had no Attorney there to represent me; that is the only reason I was found guilty. I had always gone to The Legal Aide In Montgomery County or hired an Attorney here in the county. This incident had taken place in Philadelphia and I did not know how to get an Attorney. I had tired to apply for an Attorney here in the County, but was told that they could not help me because the incident had taken place in Philadelphia. Sir, The Police officer that was at the house where the fire took place was not in the courtroom the day the trial was held. He had been in the court room all of the other times, but that day he did not come. I tired to defend myself. I was told to come back about two weeks later to turn myself in, to start my sentence. Two weeks later, when I came back to court to start my sentence the Police Officer was there, he told the Judge that I was not the woman that he had seen and when the

Judge found out the details of the Police chase, and that I did not even know the people where the fire took place, she appointed me an Attorney, and ordered him to file for a new trial, and a reconsideration of sentencing. The Attorney that the Judge appointed me filed for the reconsideration of sentencing, about a week later.

A Court Hearing was held about a month later and the Judge reconsidered my sentence to 1 day, time served and ordered that the Attorney file a petition for a new trial. Sir I am enclosing a copy of my F.B.I. Report, which will attest to this fact. The Judge name was Honorable Judge Carolyn Temmins. Sir, I was so grateful to Judge Temmins. I promised her that I would never again in my life get into any trouble, I was 34 years old when this took place in Philadelphia in 1984, and I didn't have any serious trouble with law enforcement until members of Horsham Police dept. as well as members of Bright Hope Baptist Church, and members of the Media, started breaking into my home in Horsham in 1990. Sir I have a website that has all of the papers concerning this matter list there.

From July 1990 until present, my life and that of my daughters has been a living hell. Both district attorneys, Bruce Castor and Mike Marino, and other members of the Government, and the Media, have done everything they can to disrespect, victimize, vilify, and completely destroy our lives, as we had known it. I do understand that Mike Marino after me catching members of the Horsham Police Dept, as well as members of the Media breaking into my home, sought to cover-up this fact by contracting Metro Network Service/Viacom to monitor into our home. Sir this is a fact, and the F.B.I knew all about it as did the Attorney General, as well as the National Security Agency, and other Government Officials. These are facts Sir. There is so much more to this story, but Please Sir take a look at my Website, there you will find the letters, Police reports, etc. which will show you that I have done everything I can to bring this matter to a close, and to get answers and to why it is occurring. No one regardless of the crime that they are thought to have committed should have been forced to live under the conditions that we have, being wiretapped, and the media, etc. listening in as if we are doing a T.V. show or radio show.

Judge Smyth, If you were to please take a look at the F.B.I file that I am enclosing with this letter, you will find that I have never had any other arrests, other than those due to this wiretapping, and that case in Philadelphia due to mistaken identity. Bruce Castor, as well as Mike Marino believe that they and the Government can do what ever they please to me and my daughter and if we even question why they are wiretapping us and, put a tracker on our cars and let members of the media, as well as other listen in to our home, that we will never say anything because we are afraid of being arrested, for no more than insisting that they tell us why. They call it terrorist threats if I ask why they are breaking into my home. Yet no one will tell me why they are committing this lawless act of racism against us, or bring to justice them that are doing these acts against us.

Sir please know that I have tired to deal with this situation for the last 15, now going on 16 years. It cannot continue. We are humane being and no humane should be expected to endure what we have been made to. I have never considered myself to be an entertainer, and to have my life and that of my daughters played out everyday as if I was on radio or tv, is the most insane, humiliating, inhumane, cruel and unusual punishment I have ever heard of in my life. Bruce Castor, and Mike Marino, as well as the Horsham Police, and the media, as well as other Government Officials, Presidents, have shown my daughter and myself total blatant criminal disregard for our lives. I have lost everything that I owned, and now Castor is out to get my daughter,. I cannot, Sir allow that to happen.

Bruce Castor has even tried to make a case against her for buying knock off designer handbags. Sir, she was raised and educated here in Montgomery County, right here in Blue Bell, she never even leaves out of the County other then to go get her hair done, and when sent by her job on business trips. Castor nor any member of the Government, etc. had any reason to ever think that she was involved in any crime. No one who knows her or me would have ever thought such a thing. I have tired to live my life the best that I can. I would never have even known any of the people that made a complaint against me, if I had not joined Bright Hope Baptist Church. Louise William Bishop, and others there in Philadelphia, really did believe that because my daughter and I both had new cars, and that I owned my home in the County that I was doing something illegal. Sir, every thing that I owned I got it legally. My life here in Montgomery County is an open book. My divorce, property settlement etc. was handled right here in Montgomery County Court House. There has been many wonderful caring people here in Montgomery County who have helped me during the last 35 years of my life here in the county. Sir I truly Thank God, that I never had to do anything illegal, this is a fact, and a matter of public record, right there in the Court House.

Mr. Kravitzs is my court appointed attorney. He is a wonderful man, he wanted me to take another psychiatric examine, I have already taken one in regards to this case. Sir, pleading before you guilty because of mental illness, is not going to help this situation. Sir, I have never had any psychiatric problems before I came under this surveillance, nor do I now. I understand that the District Attorney is using the Mental Health system to cover up the fact that he can't answer in court, why we are under surveillance, because my daughter, nor myself have ever committed a crime, and him nor the government has no legal reasons or probable cause to be doing so.

I built my home in 1978 in Horsham; I was separated from my ex. husband the next year. I worked, maintained my home, and raised my daughter, from 1979- 1997 by myself. Other then me having cancer, and not being able to work for a while, I think my life has been alright up until this situation. I truly believe that God only put on you as much as you can bare. I never thought I would ever see the day in this country, where a person's home could be broken into by the government, wiretapped, and subjected to surveillances, and if the homeowner protested it or ask why, they were put in jail and certified criminally insane, as in my case. Mike

Marino and Bruce Castor has treated me and my daughter as if we have no rights as human beings. I understand also that the Government, as a reason for this wiretapping us is claiming that I am not an American citizen. This is just another one of their lies. I am enclosing a copy of my F.B.I report for your inspection, you will see that before this started here in Montgomery County, which stated in 1990, I had no other incidents with law enforcement, other then the case in Philly in 1984. this to you will see in the F.B.I report that I am enclosing for your inspection. No one will ever know how hard all of this has been for my daughter and myself.

There is not one person in Montgomery County that will say that I ever gave them any trouble. My daughter is very well respected on her job, and this has been traumatic for her. The D.A. has even accused her of some misuse of her credit card. Sir this is a lie. The American Express Card that he and the Government are trying to use to justify this wiretapping, and surveillance of her also is a lie. The American express card in question belongs to her. She did a favor for a woman on her job, while doing a Trade Show about three years ago, and let the woman charge a large amount to her card that was job related. The woman turned in the receipts for the purchase, but was laid off the next week and got the money from the company and did not reimburse my daughter. My daughter got stuck with the bill. She has been paying it off a little each month. Bruce Castor and the Government are just trying to find any excuse to justify this unspeakable act of racism, they have perpetrated against us. This expenditure did not occur in respect to her credit card, until 2003. We have been under surveillance since 1990. They have placed microphones, in our cars, and every room of our home. They have a tracker on our cars. The media and government satellites follow us wherever we go. You Sir, say this sounds crazy? then please try and imagine me and my daughter living with it 24 hrs. a day for the last 15 going on 16 years. Bruce Castor, and the media, and this government is out of control. I have tired for the last 15 years to find out why we came under this investigation, and surveillance, from the Police, and the District Attorneys. Bruce Castor, nor the Government, will never admit they did it, because they had no legal reason for doing it. I feel that as a American Citizen, I have a legal right to address a grievance with my Government, that it is one of my most important basic fundamental rights as a citizen of this country. The government has no right to continually break into my home, and that of my daughters, wiretap and surveillance us, track us in our cars, allow media to do the same and refuse to tell us why. We have a constitutional right to be confronted by our accusers. Bruce Castor feel that he can do all of this to us, and if I ask why, then he claims that I am mentally ill. Sir, this situation that is very well known, it is a disgrace to the courts to continue to try and cover it up with these sham prosecutions as Bruce Castor is doing. I have had to face the reality of what is going on. Bruce Castor needs to do the same, and deal with the fact that I know, and that it is not a delusion to me and my daughter. Then maybe he will know better how to deal with this disgraceful illegal situation, that him and Marino has created. What is going on is a disgrace to the laws of this country.

Honorable Judge Smyth, I only have one child, and I love her more then anything

on this earth. If I could get pass what is going on, I would. I can't. I will never be able to live a normal life as long as I know that I am being listen in on by every member of the Media, Government Officials , etc. Sir that is my reality. I can't play with it. What is going on here is wrong. It has to come to an end.

Sir that is why I am writing you. Please don't feel that I am being disrespectful to you or the Court, for me not taking another psychiatric examine, I have refused. It will not do any good for me to plead insane Sir, that only has made the this matter worse, and given the government, Bruce Castor, and the media, etc. more assurance that they can do anything to me, as well as my daughter. They assume that as long as they have a diagnosis of mental illness against me, that they can doing anything they want to me, and claim I am schizophrenia, delusional. Sir, Bruce Castor, should have realized that when he and Marino contracted media to do the surveillance and monitor our phones etc. that everyone in the news media would be listening in. Sir I have lived for years now with, the media and police helicopters, planes, and the governments satellites, etc. flying over our home, and following us, that I could never say it is a delusion, if I ever did, I would indeed be, schizophrenia, delusional. I must deal with the reality of this situation. Please understand. They have all went too far, and with the laws that are out there now, such as the Patriots Act etc. there is no drought we will see a lot more of this in this country, due to racism, greed and blind ambition.

Sir I have also filed today a Motion For Disclosure. I understand that this has not yet been done, I have also enclosed with this letter, a copy of the that motion, as well as a copy of the FOIA request, that I have sent to the Department of Justice in Washington D.C. , and a Motion For Change Of Venue/ Motion To Transfer this case to another jurisdiction. Sir, please know that this is not any reflection on you, but in the interest of justice, this case should be moved out of the county. The facts speak for themselves that, the District Attorney has misused the mental health system, to ovoid and obstruct justice, and due process of laws. This case especially should not be heard in this county, because the complaining party is the district attorney himself. Sir there is no way that I can get a fair trial in this county.

Sir I have to try and get my daughter's and my life back. This has been going on for 15, now going on 16 years. No one, unless they are truly schizophrenia, delusional, could live out the rest of their life like this. Please Sir Understand I must try, my daughter's and my life depends on it. We are now living in a time in this country were there are those who think they are above the law, I never will believe anyone Sir, is above the law, not even Presidents, that is why I must keep trying to fight to get justice in this matter. I have wrote both Clinton and Bush concerning this matter, I am also enclosing a copy of the reply that I received, from the Attorney Generals Office, after the Bush Whitehouse sent it to them for investigation. There was never an investigation, had there been this matter would have been resolved years ago, and there would not have been any need for all of the sham prosecutions, and illegal comments to mental hospitals etc. The Clinton as well as Bush and their administrations are well aware of what is going on here in

Montgomery County. It is a disgrace how these two presidents have sit and aided and abetted, and encouraged this disgusting, inhumane injustice, for all these years.

I Pray that you will find time to read this letter and the one I wrote to the attorney general. I am sorry if I have taken up your time. I just felt it imperative that you hear from me, my side of this case. So you will better understand how I feel. Sir, I made a terrible mistake the last time I was bought to trial by Bruce Castor on a similar matter as this, before The Honorable Judge Maurino Rossanese. I was so angry at Judge Rossanese at the time of my trial for not understanding what Castor and the Government was doing to me. I was wrong Sir, it turned out that Judge Rossanese was only trying to help me, and I was so embarrassed and ashamed for having thought he was trying to hurt me. I said that I would never accuse anyone again as long as I live. I believe he was just trying to make a bad situation better. I know that now, and if he had been told the real truth he would have seen this situation differently. I truly believe that Sir. That is why I am writing you. I have told you the truth Sir, and no Government Officials, Castor, Doctors, or the Media, or even Presidents, etc. can change the reality of this situation, that we all find ourselves in. I am trusting God, that one day it will all come out, as to what took place here in Montgomery County PA. concerning this matter, so that no one else will ever have to endure what my daughter and I have. What is going on here is characteristic of every thing that is going on in our country, that is wrong, the war, economy, etc., and a clear indication of what this administration, as well as the previous, and government officials, feels is appropriate, and will prove to be one of the most shameful periods in the history of our United States, and a disgrace to Our God, and country.

I have the deepest respect for the laws of this country, that is way to me this has been the most deliberately lawless, dehumanizing, and cruel act that I have ever heard of by Government Officials, done publicly.
